

# NFC Holiday Sweepstakes Rules

## 1. Eligibility

## 5. How to Enter

Sweepstakes Via Mail: Mail in entries must be sent before December 13, 2012. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth and email address (optional) with blue/black ink and mail in an envelope with proper postage affixed to: 100 Rialto Place, Suite 700, Melbourne, Florida, 32901. Mail-in entries must be hand-printed and mailed in separately. All mail-in entries must be postmarked by December 13, 2012 and received by December 15, 2012.

Prizes are encoded on a Mifare Ultralight NFC Forum Type 2 Tag and selected at random to be shipped to sweepstakes entrants. The odds of being selected are 1 in 300. The winners are required to notify Web Evolved, LLC. before January 1, 2013. Winners must contact Web Evolved, LLC via [WebEvolved.com/contact](http://WebEvolved.com/contact); The message must include the winner's full name, shipping address for the prize, and the Prize No. encoded on your NFC Holiday Sweepstakes Tag. If the winners do not contact Web Evolved by January 1, 2013, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

## **7. Winner Notification**

Winners are required to notify Web Evolved, LLC. before January 1, 2013. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorneys fees) and any other remedies from any such person to the fullest extent permitted by law. jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Sweepstakes; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) lost, late, incomplete, garbled, illegible, undelivered, stolen, damaged, delayed, postage-due or misdirected mail, entries, application downloads, (e) any other errors or problems in connection with the Sweepstakes, including, without limitation, errors that may occur in the administration of the Sweepstakes, the announcement of the winner, the cancellation or postponement of the event and/or the flyover, if applicable, the incorrect downloading of the application the processing of entries application downloads or in any Sweepstakes-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Sweepstakes or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Florida, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Florida.
